COUNT ONE STATEMENT OF OFFENCE

USING PUBLIC OFFICE FOR PROFIT, contrary to section 179C (b) of the Criminal Offences Act, 1960 (Act 29).

PARTICULARS OF OFFENCE

IBRAHIM KOFI SESSAH, Thirty (30) years, Technician at Local Government Service, Adeiso District; between January 2022 and December 2023, in Accra in the Greater Accra Region of the Republic of Ghana and within the jurisdiction of this Court, in your private capacity, acted in collaboration with ANTHONY GYASI (AT LARGE), a public officer and IT Officer at the Head Office of Ghana Education Service (GES), to corruptly abuse ANTHONY GYASI's public office for private profit through the unlawful sale of Ghana Education Service (GES) appointment letters to prospective teacher applicants, by using your Zenith Bank Account Number 0004010951648 to receive the proceeds of the said unlawful sale of appointment letters amounting to Six Million, Forty-Two Thousand And Six Hundred Ghana Cedis (GHS 6,042,600.00) on behalf of the said ANTHONY GYASI.

COUNT TWO STATEMENT OF OFFENCE

GIVING BRIBE TO INFLUENCE A PUBLIC OFFICER, contrary to section 252(1) of the Criminal Offences Act, 1960 (Act 29).



PARTICULARS OF OFFENCE

IBRAHIM KOFI SESSAH, Thirty (30) years, Technician at Local Government Service, Adeiso District; between January 2022 and December 2023, in Accra in the Greater Accra Region of the Republic of Ghana and within the jurisdiction of this Court, under the colour of being able to unduly influence one ANTHONY GYASSI (AT LARGE) in respect of his official duty as an IT Officer at the Head Office of the Ghana Education Service (GES) by obtaining the said ANTHONY GYASI to unlawfully cause GES appointment letters to be issued to One Hundred (100) prospective teacher applicants at a fee, accepted monies amounting to Five Hundred And Eighty Thousand Ghana Cedis (GHS 580,000.00) from the One Hundred (100) prospective teacher applicants as valuable consideration for the issuance of GES teacher appointment letters to them.

COUNT THREE STATEMENT OF OFFENCE

MONEY LAUNDERING, contrary to section 1(2) of the Anti-Money Laundering Act, 2020 (Act 1044).

PARTICULARS OF OFFENCE

IBRAHIM KOFI SESSAH, Thirty (30) years, Technician at Local Government Service, Adeiso District; between January 2022 and December 2023, in Accra in the Greater Accra Region of the Republic of Ghana and within the jurisdiction of this court, knowing that the amount of SIX MILLION, FORTY-TWO THOUSAND AND SIX HUNDRED GHANA CEDIS (GHS 6,042,000.00) which you received in your Zenith Bank Account with Account Number 0004010951648 were proceeds of unlawful activity, namely unlawful sale of Ghana Education Service (GES) appointment letters to prospective teacher applicants, transferred the said amount to ANTHONY GYASI (AT LARGE), an IT Officer at the Head Office of Ghana Education Service involved in the unlawful sale of the Ghana Education Service appointment letters to prospective teacher applicants, to conceal the illicit origin of the Six Million, Forty-Two Thousand And Six Hundred Ghana Cedis (GHS 6,042,600.00).

COUNT FOUR STATEMENT OF OFFENCE

ABETMENT OF CRIME; TO WIT USING PUBLIC OFFICE FOR PROFIT, contrary to section 20(1) and section 179C (b) of the Criminal Offences Act, 1960 (Act 29).

PARTICULARS OF OFFENCE

GLORIA ACQUAH, Thirty (30) years, Nurse at Dansoman Polyclinic, in the Ablekuma Municipality, in Accra in the Greater Accra Region of the Republic of Ghana and within the jurisdiction of this Court, between January 2022 and December 2023, in your private capacity, did abet IBRAHIM KOFI SESSAH, Technician at Local Government Service, Adeiso District, who in his private capacity, acted in collaboration with ANTHONY GYASI, an IT Officer at the Head Office of Ghana Education Service (GES) (AT LARGE), to corruptly abuse the said ANTHONY GYASI's public office for the private benefit of IBRAHIM KOFI SESSAH and ANTHONY GYASI, by collecting the sum of Fifty-Five Thousand Ghana Cedis (GHS 55,000) from eleven (11) prospective teacher applicants and giving same to IBRAHIM KOFI SESSAH, for the purpose of unlawfully securing Ghana Education Service appointment letters for the said prospective applicants through the said ANTHONY GYASI.

BRIEF FACTS

Based on criminal intelligence, the Office of the Special Prosecutor (OSP) commenced investigations on 9 January 2024 into the illegal sale of Ghana Education Service (GES) appointment letters to prospective applicants seeking to be recruited as teachers into GES. The intelligence disclosed that the first accused person, a Technician at Local Government Service, Adeiso District, acting together with other persons and officials of GES solicited money from prospective teacher applicants, generally graduates from various teacher training institutions to corruptly secure their appointment into the GES.

Investigations by the OSP established that the issuance of the appointment letters to prospective teacher applicants was made possible due to the involvement of the accused persons herein, acting together with some other suspects, including (1) ANTHONY GYASI (AT LARGE), an IT Officer who works at the head office of GES; (2) SADIA ALHASSAN (AT LARGE), a Teacher at Philip Quaque Boys Basic School under GES, and (3) FRANCIS ASARE (AT LARGE), a private businessman. The investigations further revealed that the first accused person upon the instructions of ANTHONY GYASI received huge sums of money into his Zenith Bank Account No. 4010951648. These consisted of payments made by prospective teacher applicants to the first accused person in exchange for GES appointment letters. Investigations so far reveal that between January 2022 and December 2023, the first accused person received a total of SIX MILLION, FORTY-TWO THOUSAND AND SIX HUNDRED GHANA CEDIS (GHS 6,042,600.00) into his Zenith Bank Account Number 4010951648 which he in turn transferred to ANTHONY GYASI (AT LARGE). Evidence from the investigations shows that during the same period of January 2022 to December 2023, the first accused person personally received the sum of FIVE HUNDRED AND EIGHTY THOUSAND GHANA CEDIS (GHS 580,000.00) from one Hundred (100) teacher applicants through the sale of GES appointment letters under the pretext of securing their appointment into the GES.

Investigations further established that the second accused person, solicited monies from eleven (11) prospective teacher applicants amounting to FIFTY-FIVE THOUSAND GHANA CEDIS (GHS 55,000.00) and gave same to the first accused person, for the purpose of securing Ghana Education Service appointment letters for the said prospective applicants. The second accused person admitted to assisting Asumah Karikari Gloria, Simon Hackman Boadi, Peggy Odame, Yvette Kyei, Afoakwa Joana Asare and Tetteh Regina Djabakie and four (4) others with their recruitment into GES.



The accused persons were subsequently arrested and have been charged with the

offences contained in the charge sheet.
